Guidelines for Candidates for Submission of Applications :

1. Application for admission is to be made online by the candidates themselves.
2. One Application is sufficient for all the courses offered.
3. A Passport size photo of the Candidate is to be uploaded in the online Application.
4. The uploading of the 12th Mark sheet /10th & ITI Marksheets and Community Certificates are to be done.
 - 4.1. ITI Candidates may upload their Mark sheets after the receipt of them.
5. The Date of Birth in the application should be same as in the 12th Certificate (Mark Sheet)
6. The candidate should enter the correct marks scored by them in each subject in the online application. Furnishing incorrect mark details will lead to :
 - a) Disqualification of the candidate for admission to this college.
 - b) Barring him/her from studying for two years.
 - c) Disciplinary action will be taken against the candidate for furnishing wrong/incorrect marks.
7. Incomplete applications will not be considered for admission.
8. Admissions will be made as per the guidelines issued by the Directorate of Technical Education (DOTE) for this purpose.
9. Candidates should submit without fail the following on the day of admission.
 - a) Transfer Certificate and Conduct Certificate issued by the Headmaster of the school last studied in.
 - b) 11th Mark Sheet (issued by the Board)
 - c) 12th Mark Sheet (issued by the Board)
(Mark Statement issued by the Head Master is not admissible)
 - d) 10th & ITI Mark sheets (for ITI students)
 - e) Original Community Certificate.

Applications can be made online by the Candidates through the College Web Site : www.palaniandavarpc.org.in The Cost of the application is Rs.150/- (Rupees one hundred and fifty only) can be remitted online by Debit Card/Credit Card/Net Banking. [Candidates belonging to SC/ST Category need not pay cost of Application]

11. Applicants belonging to SC/ST Category can upload their application without paying cost of application.
12. A service centre facility has been set up for students who shall come directly to the college and upload the student admission application form through the website free of charge. Students can utilize this service centre facility to apply any of the four colleges through online run by the Arulmigu Dhandayuthapani Swamy Thirukoil Management.
13. All Candidates admitted in Govt. aided Courses can avail scholarships issued by Government of Tamilnadu based on eligibility.
14. SC/ST Candidates admitted in Self Supporting Courses are eligible for Scholarships granted by Department of Adidravidar Welfare, Tamilnadu.
15. Candidates possessing the following qualifications as on 01.08.2022 only are eligible to apply.
16. **Nativity:** Candidates belonging to Tamilnadu alone are eligible.

17. **Educational Qualification:**

- A Pass in HSC with
Physics/Mathematics/Chemistry/Computer Science/Electronics/Information Technology/
Biology/Informatics Practices/Biotechnology/Technical Vocational subject/Agriculture/
Engineering Graphics/Business Studies/Entrepreneurship (Any of the three)
(or)
- 10th Std Passed and 2 years ITI passed in any branch of Engineering and Technology.

18. **Age Limit:** There is no age limit prescribed for seeking admission.

19. **Communal Reservation for admission :**

The admissions will be based on the following categories of reservation of seats.

- a) Open Competition (OC)
 - b) Backward Community (others) (BC(O))
 - c) Backward Community (BC(M))
 - d) Most Backward / Denotified Community (MBC/DNC)
 - e) Scheduled Caste (SC)
 - f) Scheduled Caste – Arunthathiar (SC(A))
 - g) Scheduled Tribe (ST)
- 19.1 Applicants belonging to SC/ST/SC(A)/MBC/DNC/BC(O)/BC(M) categories should submit their permanent Community Certificate at the time of admission. If a caste is notified as a certain category in specific Districts/Taluks of the state, the Community Certificate of such Candidates should have been obtained from the authorities of the same district.

Remarks :

1. SC Candidates converted to Christianity will be considered as BC(O) candidate only.
 2. Converts from ST Category to other religions will be considered as belonging to that religion only.
 3. SC Candidates, who reconvert from other religion should furnish the date of such reconversion, accepted by the members of the original religion. The gazette notification for reconversion into Hinduism from Christianity should have been issued prior to 1st July of the Year of Admission.
 4. ST/SC/SC(A)/MBC/DNC/BC(O) are eligible to be considered for admission in the open category also.
 5. The Community certificate in respect of ST candidates is to be obtained from the respective RDO/Collector/PA(G) of the District collector of Chennai only.
20. Candidates will be selected based on the mark scored by them in +2 or equivalent exam and following the Communal reservation rules in force. If the maximum mark of any qualifying examination is more than 600, the marks obtained by the Candidate in such exam will be converted to the Max. Mark of 600.
21. Ragging in any form is prohibited in the College campus and those who indulge in ragging will be liable for criminal action as per the rules in force
22. Separate hostel facilities are available for Boys and Girls.
23. Girl students who studied in Govt. Higher Secondary School will receive a scholarship of Rs.1000/- per month from the Government of Tamil Nadu.
