I am directed to state that the subject "Misconduct of College students and School students" was taken up for discussion in the Law & Order Meeting chaired by the Chief Secretary on 28.01.2023.

2. In this connection, I am to request you to instruct all the educational institutions viz. Government, Government Aided, Self-financing colleges, Autonomous colleges and Deemed to be Universities under your administrative control as follows:-

- i. The college authorities might be instructed to enhance lawful measures to discipline the students through counseling during assembly hours / through media, apart from moral inculcation in every class.
 - ii. The problematic students might be profiled and given regular counseling through psychologists along with their parents and it might also be reiterated that criminal action would be taken if the students indulge in repeated offences or involved in hurt cases.
3. I am, therefore, to request you kindly to pursue further action in this regard and to send a detailed action taken report on the above mentioned subject to this department, immediately.
